It's hard to go wrong with a neatly-trimmed right-of-way

All those dreams over the seed catalogs this winter are about to come true. Longer daylight hours and warmer temperatures have many of us getting ready for spring cleaning, yard work, gardening and even some tree planting. As enjoyable as spring is, the changing of the seasons does bring some concerns for the coop.

Severe weather can be triggered by rapidly warming air temperatures. Thunderstorms can snap limbs from trees. To protect our lines from those falling limbs and keep power flowing safely to your home, Valley Rural Electric Cooperative employs an aggressive right-of-way (ROW) maintenance program. Think of it as spring cleaning for power lines, even though the effort continues all year.

Maintaining ROWs is our largest operations expense. But it's a critical part of the service we provide to you for three reasons: safety, reliability and cost.

If severe spring weather blows through, having a well-maintained ROW leads to fewer outages and faster response time, increasing overall reliability. Right-of-way maintenance keeps tree limbs and other vegetation away from high-voltage power lines, lessening the chance that vegetation will come into contact with lines during a storm or until the next maintenance cycle. Past data shows the highest percentage of power outages for the cooperative is caused by unhealthy or dead trees that fall into the right of way. As part of our ROW maintenance, structurally unsound and dead trees are identified and removed to prevent them from contacting the facilities should they fail.

When trees and limbs do reach our lines, crews are able to restore service more quickly in well-maintained areas because they are easier to access.

Our primary concern is the safety of our workers and members. A properly maintained ROW helps keep our crews safe when they are restoring service and maintaining our system. Keeping

vegetation clear of power lines also keeps your family safe. From ensuring limbs near a child's tree house don't hit power lines to creating a safe environment while doing yard work, a well-maintained ROW helps avoid tragedy.

As a not-for-profit company, Valley strives to keep costs affordable for members. Aggressive maintenance helps control costs because fewer and shorter outages saves money for everyone. When crews work in those well-maintained areas and risks for employees and equipment are reduced, costs are kept lower too.

Power lines are a constant part of our landscape; it's easy to forget they are around. We work hard to keep the area around our lines clear, but we need your help. Don't plant trees or tall vegetation under power lines, and keep an eye out for power lines when working in your yard. If you see vegetation closing in on co-op lines, let us know.

Safety, reliability and cost: This is why we believe in doing our "spring" cleaning. If we compromise on one of these areas, it impacts the others. At Valley REC, we aren't willing to compromise. Maintaining our ROW is a priority — for your safety, your comfort, and your pocketbook.

Former Penn State University cornerback Adam Taliaferro will be the guest speaker at Valley Rural Electric Cooperative's 2014 Annual Meeting. Taliaferro was paralyzed while making a tackle for Penn State in a game at Ohio State in 2000. After spinal-fusion surgery, doctors said he would probably never walk again. Three months later he walked out of a Philadelphia hospital.

He now works with the Adam Taliaferro Foundation, which provides emotional, financial and educational support to student-athletes who suffer catastrophic head or spinal injuries.

The 2014 Annual Meeting celebrates the co-op's 75th year. The event is set for 7 p.m. Friday, April 11 at Mount Union Area High School. Doors open at 5:30 p.m. with a presentation of scenic slides at 6:30 p.m. The business meeting begins at 7 p.m.

Co-op board candidates chosen for ... Districts 1, 3, 5

IN FEBRUARY, more than 200 co-op consumers gathered at nominating meetings held to select board candidates for Valley Rural Electric Cooperative districts 1, 3 and 5.

Since 1975, Valley has been holding open nominating meetings where co-op members can choose candidates for the co-op's board of directors rather than relying on a nominating committee appointed by the board.

In 1989, those open meetings started to include full-course meals, offered to all participating consumers.

Each year Valley holds nominating meetings in three of its nine director districts. Members residing in those particular districts are invited to attend. Next year, members will nominate board candidates for districts 2, 4 and 6.

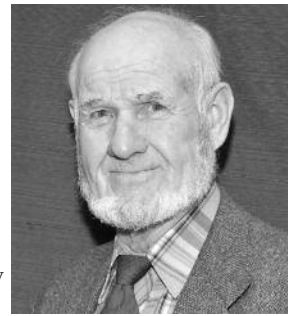
Tim is a member of the Memorial Church of the Brethren in Martinsburg and the Martinsburg Booster Association.

April recently quit her job to stay home with Brielle. Matt, a local contractor, has kept his business going, to keep his employees working, by traveling back and forth to Pittsburgh. Costs for meals, fuel and rooms have added up, not to mention the medical expenses.

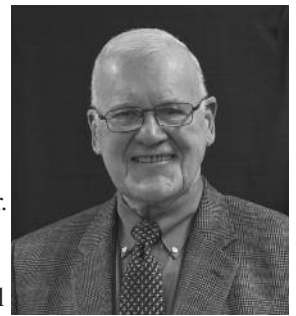
