*Dalana Snyder, 18, is a senior at Mount Union Area High School (graduating in June 2025). She is the daughter of Dale Hamman and Robin Snyder of McVeytown. In April 2024 she was diagnosed with acute myeloid leukemia after bleeding complications from tonsil/adenoid surgery. Dalana developed multiple infections through her first four rounds of chemo, but thankfully the cancer is in remission. She is taking a chemotherapy pill all this year and still must make many trips to doctors in Lewistown and Danville.*



*One-year-old Theodore Joseph Hess-Garcia is the son of Collin Hess and Isabel Garcia-Fernandez of Waterfall. Theo was born with an airway disorder that requires him to use a ventilator and a feeding tube. He has a brain condition that led to epilepsy and will need hip surgery later this year. Though he will require lifelong care, Theo's family is hopeful about his prognosis.*
