Balancing buzz with common sense

MY KIDS OFTEN get excited about the latest gadget to hit the market. It might cost a bit extra, but they simply have to have it. I never quite understood that excitement -- until now.

At Valley REC, we've read about and begun implementing aspects of the so-called "smart grid." As with any cutting-edge concept, it seems new smart grid bells and whistles are touted daily. While we've been careful not to get caught up in too much of the hype, I often have members ask me, "What's all the buzz about?"

The North American electric grid, the largest interconnected machine on earth, operates as a humming highway moving electricity from power plants to your home. About 3,000 utilities operate 10,000 power plants nationally. All of this power -- more than 1 million megawatts -- flows across 300,000 miles of high-voltage transmission lines. And while the way we use electricity has changed drastically over the decades, most of the highway that delivers power to our homes was built 50 years ago.

As we talk about upgrading the nation's grid from a hands-on, mechanical system to a digital network, there's plenty of room for improvement (and potential miscalculations). While a smart grid can help utilities control costs, it can also be abused by big power companies and others to shift market risks onto consumers -- something your cooperative doesn't want to see happen.

That's why, with some help from Uncle Sam, not-for-profit, member-owned electric utilities are testing some of these technologies to see what makes sense. Thanks to partnerships between the federal government and electric cooperatives, public power districts and NRECA's Cooperative Research Network, more than \$600 million will be invested to deploy and study how digital smart grid technologies improve service for co-op members in 25 states (including Pennsylvania).

On top of this, many other co-ops are implementing smart grid upgrades consistent

with long-range business plans to boost service reliability and operating efficiency.

Through all of these efforts, we will identify which technologies work best and weed out those that may not deliver promised benefits.

Any smart grid needs to be flexible -- some components don't make sense everywhere. Here at Valley, we believe automated meters and self-healing feeders will help reduce the number and duration of outages; in-home displays could increase member awareness of how much electricity they use; there are lots of possibilities. Rest assured that your management team will employ some hometown smarts of our own in how we approach the smart grid.

Our bottom line? We want to learn how to help you make wiser energy choices to keep your electric bill affordable.

Co-op awards 25 \$1,000 scholarships to local students

VALLEY RURAL ELECTRIC Cooperative recently awarded 25 \$1,000 scholarships to high school seniors as well as students already enrolled in post-secondary institutions and returning adult students.

The co-op's Brighter Future Scholarship Program was established this year to assist eligible students who are cooperative members or their dependents. Selection criteria include academic achievement, financial need and community activities.

The money to finance this initiative comes from unclaimed capital credits refunds that previously had to be turned over to the state treasury. But now, thanks to the efforts of the cooperative's political advocates, these resources can be kept in co-op communities and used to assist consumers facing financial hardships and to fund educational scholarships.

ON-THE-JOB TRAINING: Line crews sharpen skills, improve service

LINE PERSONNEL from all three Valley Rural Electric Cooperative districts honed their skills Sept. 14-15 during on-the-job training near the co-op's Miller Substation in northern Huntingdon County.

During this particular training opportunity, crews learned to replace underground electric lines using a piece of machinery called a Duct Dawg, an underground puller with hydraulic-driven twin capstan bullwheels used primarily to draw wire through conduit.

Somerset Crew Chief Dean Gindlesperger delivered the Duct Dawg and stayed for both days to help assist Valley crews with operating the machine.

In addition, Pennsylvania Rural Electric Association Safety Instructor Bill Succowich was on hand to guide the men through the proper (and safest) steps for completing the project.

"This particular training experience benefitted Valley in a number of ways,"

says Gary Atherton, Valley's operations manager.

"With this project, we were able to minimize any safety risks. We also saved time and money while replacing worn-out underground wires in the area. Plus our crews got good training, maximized their efficiency and ultimately improved members' service. It was a win-win situation all around."

EXTENSION CORD SAFETY: Make smart connections

FAMILIES OFTEN string together extension cords without a second thought (particularly during the holiday season). Unfortunately, not all cords are created equal.

Just because an extension cord can reach an outlet across a room doesn't mean it's the right one for the task at hand. If a tool, appliance or decorative display draws more current than an extension cord can carry, it may cause the cord (and whatever is connected to it) to overheat and start a fire.

Cords come in many lengths and are marked with a size or gauge. The gauge is based on the American Wire Gauge (AWG) System, which indicates that the larger the size of the wire, the smaller the designated AWG number.

For example, a 12-gauge wire would be bigger and capable of powering larger-wattage appliances than a 14-gauge wire. A cord, based on its gauge, can power appliances of a certain wattage only at specific distances. As the cord gets longer, the current-carrying capacity of the cord drops.

Using the right cord for the job is only the first step in using extension cords safely. The following tips will help ensure safe use of

cords and allow you to make smart connection decisions:

Look for the Underwriters Laboratories (UL) symbol. The UL mark means that samples of the cord have been tested for safety hazards.

Never use an indoor extension cord outdoors; it could result in electric shock or trigger a fire. Extension cords that can be used outdoors will be clearly marked "Suitable for use with outdoor appliances."

Extension cords should not be placed underneath rugs or other heavy furniture, tacked in place to a wall or taped down, or

used while coiled or bent. Match the length of the cord to your needs.

Store all cords indoors when not in use. Outdoor conditions can deteriorate a cord over time.

Unplug extension cords when not in use. The cord will continue conducting electricity until unplugged.

On cords with more than one outlet, use the covers provided for unused openings. Children and pets face serious injury if they chew on unused outlets or stick sharp metal objects into the openings.

Do not use extension cords that are cut or damaged. Touching even a single exposed strand of wire can result in an electric shock or burn.

Never file or cut the plug blades or grounding pin of an extension cord or appliance to plug it into an old outlet.

As an added safety feature, extension cords and most appliances boast polarized plugs (one blade wider than the other). These special plugs are designed to prevent electric shock by properly aligning circuit conductors. If a plug does not fit, have a qualified electrician install a new outlet.
