## You, Dear Reader, are in Good Company

I APPRECIATE OUR MEMBERS WHO take the time to flip through *Penn Lines* magazine each month. The publication's editors, writers, and contributors strive to provide interesting and relevant content. When you leaf through the magazine, do you ever wonder who else is turning the pages?

Turns out, there's a lot of info about that. The folks at the Pennsylvania Rural Electric Association (PREA), our partner in producing the magazine, regularly conduct a readership survey. Reviewing it the other day, I thought, "Why not share some stats

about you with you?"
Would you have guessed 87% of rea

Would you have guessed 87% of readers are "regulars," meaning they read at least three out of four issues? Seventy-nine percent read every issue, and the average reader has been reading *Penn Lines* for 19 years. Perhaps you're above average? Hopefully, you're a regular.

If you're reading this, there's a good chance there's a dog or cat on the couch with you, or some critters in the barn. About 64% of our readers have animals, either pets, livestock or both.

While Valley Rural Electric Cooperative (REC) serves all kinds of properties — including churches, schools, businesses and government buildings — there's a 96% chance that your co-op account is for a home you own. It's just as likely that you own a vehicle, with 64% of our readers owning a pickup truck.

It's slightly less likely, but still very probable, that you own some type of lawn, garden or farm power equipment. Ninety-five percent of *Penn Lines* readers own a lawn mower, lawn/garden tractor, tiller, chainsaw or farm tractor. I wonder how many readers own at least one of each? The survey doesn't say, but I'd bet it's a fair amount.

There's a 38% chance you work full- or part-time, but a 55% chance you are retired. That stands to reason, since many people approaching retirement determine to spend a bit more quality time with books and magazines.

Nine percent of readers are 44 or under, with 3% being between 18 and 34. I think it would be wonderful if high school students read *Penn Lines*. Surely, some do. The survey just doesn't record it. The median age of readers is 66, though many of you may be thinking, "Ha, I got that one beat!"

One of the statistics I felt was a pleasant surprise is that 41% of readers have shared a *Penn Lines* article with family or friends. That statistic is huge if you're on the *Penn Lines* team (including member-contributors who submit photos to the Rural Reflections page or art for the Community Corner page). It warms the heart to think so many readers found an item of such interest that they passed it on.

The readership survey doesn't quantify the biggest commonality among readers, however. Valley REC members, like those of all electric co-ops, rely on their not-for-profit electric distribution business to provide safe, reliable power as affordably as possible. It's an ongoing story worth writing and worth reading about — for an average of 39 minutes a month, according to the survey.

PREA will be conducting another readership survey in 2025. Please participate and tell us all about you. And don't forget to mark the boxes for dogs, cats and tractors.

## Co-op Holds Nominating Meetings in Director Districts 7, 8 & 9

IN FEBRUARY, NEARLY 250 MEMBERS

and guests gathered at nominating meetings to select board candidates for Valley Rural Electric Cooperative's (REC) Districts 7, 8, and 9. The nominees, shown on the following pages, were selected to stand for election to three-year terms on the co-op's nine-member board of directors. The election will take place at the drive-thru annual meeting, which starts at 4 p.m. Friday, April 4, at the Huntingdon County Fairgrounds.

This year's dinner meetings were held at the Hustontown Fire Hall, Fulton County; the Southern Huntingdon County High School cafeteria, Huntingdon County; and the West Loop Missionary Church, Blair County, for Districts 7, 8, and 9, respectively.

Nominating meetings are held annually in three of the co-op's nine director districts. The names of nominated members will appear on the annual meeting ballot. All members attending the annual meeting, regardless of the district in which they live, will vote for candidates for Districts 7, 8 and 9.

Valley REC President & CEO Rich Bauer provided an update about the co-op then held a Q&A session. Rich outlined some of the challenges facing the electric utility industry nationwide. Increasing demand for baseload power, in large part due to data centers, has drastically increased wholesale power costs. Coupled with nuclear power plant closures and regulations impacting coal and natural gas supplies, Pennsylvania has become a net importer of energy for the first time, Rich said.

Valley REC and other co-ops served by Allegheny Electric Cooperative, Inc. (Allegheny) in Harrisburg have largely been shielded from wholesale power market volatility due to Allegheny's 10% ownership of the Susquehanna Steam Electric Station, a nuclear plant; its ownership of the hydroelectric plant at Raystown Lake; and long-term contracts for hydropower from the New York Power Authority.

"The co-op is in great shape due to owning 67% of our generation," Rich explained. "If there is fluctuation in the market, it only impacts that 33% purchased on the open market."

Rich told members the co-op has replaced five 1950s-era substations since 2016 and will be upgrading the delivery point for the Puzzletown substation in Blair County this year. He also encouraged members who aren't participating in the demandresponse program to consider having a unit installed on their water heater to help stabilize future wholesale energy costs.

Member questions ranged from utility-scale solar projects to the sources of the co-op's wholesale energy supply. Rich thanked members for their ongoing cooperation with the co-op's project to trim trees in rights of way and said the co-op's aggressive approach

to vegetation management increases reliability.

"We average one outage per year per member," he said. "We're pretty proud of that considering the terrain we serve."

## **Meet Your Employees: Matt Fish**

Highlighted in this column is a recent addition to the Valley Rural Electric Cooperative (REC) team, Matt Fish. He was hired full time in October 2023 and currently works as a first-year lineman's apprentice in the co-op's Shade Gap District Office.

In his position, Matt climbs utility poles and uses an aerial bucket to work around de-energized lines. His goal is to become qualified to work around energized lines and become a journeyman lineman.

"I was hired as a ground hand," Matt recalls, explaining that his initial job duties included getting materials ready and attaching cross arms and hardware to new poles prior to installation.

Matt grew up in the Shade Gap area of Huntingdon County, in a home served by co-op lines. He is a 2010 graduate of Southern Huntingdon Area High School, where he was on the football, basketball and track teams. He attended Lock Haven University on a track scholarship and competed in throwing events.

"I threw javelin and the hammer," Matt recalls. "The hammer is like a shot put on a cable."

Matt has a bachelor's degree in criminal justice. However, after graduating college, he took a full-time position as a directional driller with Peterson Excavating, LLC. The company, based in Burnt Cabins, Fulton County, provides boring and excavating service for the installation of underground telecommunications lines.

"I worked for Peterson in the summer during college and went full time after graduation," Matt says. "We did drilling under roadways and streams. We worked in Maryland, West Virginia, Virginia and the Carolinas."

Matt spent 13 years with Peterson. During that time, he occasionally encountered electrical lineworkers and found their work interesting. Matt knew several Valley REC employees at

the Shade Gap office, so when he heard the co-op was hiring, he applied. Matt says he enjoys the camaraderie between the district's line crews and office staff.

"It's easy to work with the people here," Matt says. "Being part of a good crew makes it easy. There are a lot of good teachers here."
